


What should I know about being a Herbalife Nutrition Associate?

<p>How can I participate?</p>	<p>As a Herbalife Nutrition Associate, you may:</p> <ul style="list-style-type: none"> • Buy Herbalife Nutrition products at a discount for your household use. • Participate in the business opportunity by selling Herbalife Nutrition products to make a retail profit. • Participate in the business opportunity by recruiting others who want to consume or sell Herbalife Nutrition products. <p>If your only purpose in joining Herbalife Nutrition is to receive a discount on the products, you should discuss with your sponsor whether the Preferred Customer program is right for you. A Preferred Customer cannot sell products, recruit others or earn multi-level compensation, but does receive a discount on the products. A Preferred Customer may convert to Associate and build a business at any time by following the conversion process.</p>						
<p>What should I know about the business opportunity?</p>	<ul style="list-style-type: none"> • Associates enjoy setting their own schedule and choosing how and when to work. • Most people start their Herbalife Nutrition business by working part-time and selling to people they know or people they meet as a way to make a little extra money. • There are no guarantees that you will earn money. Like all business people, some Associates will succeed, while some will not. • Building a successful Herbalife Nutrition business takes skill, hard work, and time. 						
<p>How can I earn Money?</p>	<p>You can earn money by selling Herbalife Nutrition products that you buy at a discount. Your initial discount is approximately 25% of earn Base*. The more you sell, the higher your discount, up to a maximum of 50% of earn Base*. <p>In addition to retail earnings, how much could I earn from sales by Associates I sponsor?</p>	<p>In 2021, there were 231,284 Associates who had been Associates for at least 1 (one) full year. In addition to any retail profit, 37% or 85,633 of them earned commissions or bonuses from the sales of Associates that they sponsored.
